



### *CCIM Hawaii Chapter CI 101 Scholarships*

#### **Background**

The CCIM designation is the PhD of commercial real estate and is the gateway course of the CCIM Designation Program.

The CI101 scholarship(s) will be awarded to a deserving individual(s) interested in furthering their education in commercial real estate through the CCIM program.

“CI 101: Financial Analysis for Commercial Investment Real Estate” is the first course in a series of courses to obtain the prestigious CCIM designation. This course gives students a thorough understanding of financial analysis tools, concepts, and calculations to make sound decision involving commercial real estate. The course covers cash flow models, time value of money concepts, finance programs, loan terms and variables, appraisal methods, measurement of investment value and performance, and taxation issues.

The Hawaii CCIM Chapter will award a \$500 scholarship to each of two deserving individuals to be used towards the CI 101 class held in Hawaii.

Interested applicants must complete a scholarship application. Deadline for entries is October 15th of each year. The recipient will be awarded the scholarship certificate and be recognized at the Hawaii CCIM Chapter Installation Banquet in November.
